GENERAL GUIDELINES

- 1. SET UP BEGINS AT 7:00 AM ON SATURDAY. FOR THOSE OF YOU THAT WISH TO SET UP FRIDAY NIGHT, THE COMMITTEE WILL ALLOW IT; HOWEVER, BE REMINDED THAT THE EVENT SPONSOR WILL NOT BE HELD RESPONSIBLE FOR ANY LOSS OR DAMAGE. PLEASE REMEMBER IN WORKING WITH THE FLOYDADA FOLKS THAT THEY ARE VOLUNTEERS AND ARE DOING THE BEST THEY CAN.**
- 2. WE REQUIRE EXHIBITS TO BE UP BY 9:00 AM SATURDAY MORNING. EXHIBITS MUST REMAIN OPEN AND MAINTAINED FROM 9:00 AM TO 5:00 PM. EXHIBITORS WILL BE RESPONSIBLE FOR COLLECTING SALES TAX. THERE IS NO COMMISSION SALES.**
- 3. THE COMMITTEE RESERVES THE RIGHT TO BAN ANY EXHIBITOR FOR MISCONDUCT, OBSCENE OR OFFENSIVE WORK, AND THE RIGHT TO APPROVE OR DISAPPROVE THE SALE, DISPLAY OR DISTRIBUTION OF ALL MERCHANDISE SOLD ON THE PREMISES. EXAMPLES OF SUCH MERCHANDISE ARE SILLY STRING, STINK BOMBS, POTATO GUNS, PELLET GUNS, PAINT GUNS, AND KNIVES.**
